

School Board Meeting

Meeting Minutes

May 20, 2015

Board Members Present: Thomas Frischknecht, Kim Lavallee, Sarah Frischknecht, Richard Hyotte, Lenka Steiger, Kevin Ahern.

The meeting was called to order at 4:03 PM.

- 1. Public Comment Session none
- 2. Approve Minutes from Previous Meeting
- ** Mr. Hyotte motioned to approve the April 2015 board minutes. Mrs. Steiger seconded. All voted in favor.**
- **3. Proposal for overseas school trip** (Mrs. Kathleen Barlow, faculty member): Looking to plan a trip to take place in 2017. A survey was sent out to determine where the most interest was in the school community on where to go. About 120 responded, 20 were not interested; highest interest was to go to France/England, then France/Belgium/Switzerland and lastly France/Spain, so far.
- ** Mr. Hyotte motioned to approve a school trip to Europe. Mrs. Steiger seconded. All voted in favor. **

Board requests that Mrs. Barlow return with more details when she has a set itinerary and insurance information, right before she "launches" this trip.

4. Charter School Board Business

- -- Email vote to publishing of salary of Mrs. Lavallee in newspaper salary per requirement of auditors, as explained in email. All voted in favor by email.
- ** Mr. Hyotte motioned to ratify email vote for publishing Mrs. Lavallee's salary. Mr. Ahern seconded. All voted in favor.**
 - -- Email vote to allow school to seek a Bridge loan to cover expenses (employee salaries, etc) to be paid back with the first funding check in the fall. (Property taxes had to be paid this year to Manchester.) All voted in favor by email.
- ** Mr. Hyotte motioned to ratify email vote for seeking a bridge loan to cover end of year/summer expenses. Mr. Ahern seconded. All voted in favor.**

There will be no board meeting in July.

June 17 board meeting will be the Annual Organizational Meeting.

B. Treasurer Report (Mrs. Lavallee):

Next school year, the school should be exempt from paying property taxes, since the building meets all criteria for exemption.

We will reopen the budget to include the property tax fees, and review to see if additional adjustments can be made to better utilize the funds. A revised budget will be presented to the board.

- -- Have some ideas from another Franklin School for Performing Arts how to earn some money from having events held at school.
