# **School Board Meeting Minutes**

August 26, 2015

The meeting was called to order at 3:05 PM.

- 3. Board Business:
  - a. Announcements-The resignation of Mr. Frischknecht as the Chairman of The Founders Academy Public Charter School board was announced.

All voting members voted yes, Mrs. Humphrey and Mrs. Steiger voted yes by proxy.

#### 4. Dean's Report:

- a. Donations-The school received 25 desktops and 7 laptops as a result of a parent volunteer approaching BAE and working with the school to receive the donation.
- b. Department Chair Organization-Three department chairs have been named, Maria Bechis will chair the Science, Math and Technology Department, Greg VanEyck will chair the Humanities Department and Greg McKenzie will chair the Music and Visual Arts Department.
- c. Additional Items-New website is moving forward under the supervision of Joanna Marcotte. Teachers are working on their pages and uploading information for students and parents.

- 6. Faculty Report-Mrs. Bechis updated the board on the various field trips the school will be participating in over the 2015-2016 academic year. She expressed her concern the need for various supplies and textbooks needed but understands the school's frustration due to budget constraints. Several teachers have used Donor's Choose and been successful. She will be looking into various technology and ways to fund purchases outside of the budget, believes grant writing would be very helpful.

- a. Finance-The line of credit was obtained and is being utilized this month. An updated budget will be presented in September. The financial audit will be presented at the September 16, 2015 board meeting and is on track to be submitted on time.
