Update from Director of Curriculum, Assessment, and Instruction (Christine T) See attached report here. After Mrs. Tyrie's presentation there was a discussion regarding the Board Sub-Committee of Curriculum. Scott P will chair this committee and work closely with Mrs. Tyrie and all of the stakeholders to make sure all are represented while gathering feedback on how curriculum is developed, instruction is delivered and mastery is assessed. Meetings will be announced on the school calendar.

Admissions update: As of 8/18/21 - 201 applications for the 21/22 school year. 168 of them are complete (see Dean's report for specific grade breakdown of applications)

After recommendation by Manchester Police Department, Founders has acquired InForce 911. This app will allow staff to communicate directly with Manchester Police without going through the 911 service.

Discussion with the board and the Administration regarding faculty and staff turnover. Dean Hayes and Mrs. Tyrie both reported there is a national shortage of teachers and the majority of schools are seeing higher than usual turnover and difficulty hiring staff due to COVID. Board Business
